Financial Assistance

For persons with cancer

This handout lists services to help cancer patients with financial needs including:

- Washington State assistance.
- Federal assistance.
- · Veterans' assistance.
- Employment concerns.
- Help if you are low income or disabled.

If you have no income, are unable to work for a period of time because of your illness or treatment, and you will need financial assistance or assistance with your medical bills, there are two options. In many cases, you will want to apply for both:

- Washington State Assistance (DSHS)
- Social Security Disability or Supplemental Security Income (Federal Assistance)

Washington State Assistance: Department of Social and Health Services (DSHS)

Local welfare offices are listed in the blue pages of the Seattle telephone book under "Washington State Community Service Offices." You can get an application form from the UWMC Financial Counseling office on the 3rd floor, near the main entrance. If you are found eligible for public assistance, you will get a monthly check and Medicaid to cover the costs of your medical treatment and medications.

Even if you are not considered low income enough to receive financial assistance, you may still be eligible for partial coverage of your medical expenses. It is important to apply as soon as possible, as it may take a month or more for your application to be processed. A counselor in the UWMC Financial Counseling office can help you with your application or with reapplying as needed. The office number is **206-598-4320**.

Social Security Disability or Supplemental Security Income (Federal Assistance)

If you are disabled by your illness or treatments, you may be eligible for Social Security Disability (SSD) or Supplemental Security Income (SSI), which will provide you with income and medical coverage.

Social Security defines "disability" as "physical impairment which prevents you from doing any substantial gainful work...and is expected to last (or has lasted) for at least one year..." If you think you may be eligible for SSD, you can begin your application over the phone. There is a 5-month eligibility waiting period for SSD. SSI, however, is an income-based program and there is no waiting period.

Veterans

Employment Concerns

UWMC Rehabilitation Medicine Department

If you and your doctor feel your illness has limited your ability to work, vocational counselors in the UWMC Rehabilitation Medicine Department are available to assess your needs and options for returning to work. These counselors may also be helpful advocates in working with employers to request extended sick leave and to avoid job termination. If you are interested, ask your doctor for a Rehabilitation referral. Check with your insurance provider to make sure your insurance will cover this service.

The Division of Vocational Rehabilitation (DVR)

DVR, a state agency, offers employment counseling and training for people with disabilities related to illness or injury who are capable of participating in training or employment. They have local offices in many cities throughout Washington state. In Seattle, their phone numbers are listed in the blue pages of the telephone book under Washington State, Vocational Rehabilitation. The main office number is:

Protection Against Job Discrimination

Under federal law and many state laws, it is illegal for an employer to discriminate against a worker because he or she has cancer. Some protections are offered through the Americans with Disabilities Act and the Federal Rehabilitation Act. The ability to take additional medical leave without risking job loss is provided to workers in many circumstances under the Family and Medical Leave Act.

For more information on these laws, contact the National Coalition for Cancer Survivorship (NCCS) or the American Cancer Society (ACS). ACS can send you a brochure, *Americans with Disabilities Act: Protection for Cancer Patients Against Employment Discrimination*, which defines the ADA law by describing employment rights of the cancer patient. Low-Cost Bus Pass

Metro-Regional Reduced Fare Permit 206-553-3060

This permit entitles you to discount fares on 8 transportation systems in the Puget Sound region. You are eligible if you are 65 or older, or if you are certified by your doctor as disabled by your cancer or your cancer treatment. Apply at Metro or at your local transportation agency.
